



## Guideline to Use Hanifaru Island

- 1. Hanifaru Island is protected under Environment Protection and Preservation Act 4/93. The Protection and Preservation Regulation (2012/R-23) states that EPA reserves the rights of entry to Hanifaru MPA.
- 2. Vessels are not allowed in to Hanifaru MPA, from 6:00pm to 6:00 am, hence the Hanifaru Island will also be closed at that duration.
- 3. Article 12 of Hanifaru Protection and Preservation Regulation (2012/R-23), states that a special permit from EPA must be obtained in order to enter Hanifaru Island.
- 4. The waste generated must be taken along with the group when they leave Hanifaru Island and must be properly Disposed in a designated waste disposal site

## **Permit Application**

- i. The tour organizers must send a written request for the permit addressed to Environmental Protection Agency, 5 days prior to the visit to the Island.
- ii. The request must give; the exact number of visitors, purpose of visit and duration of stay names or card numbers of accompanying tour guides.
- iii. The visitors will only be allowed to stay for 45 minutes and must observe and make sure the visit fits the five vessels at a time in Hanifaru MPA.
- iv. The application with inadequate information will be rejected and new application must be sent.
- v. Applications will be accepted as emails, letters and fax.
- vi. Environmental Protection Agency will verify and provide the permit accordingly.

## Activities Prohibited in and around Hanifaru Island

- i. Barbecue and camp fire is prohibited in Hanifaru Island.
- ii. Building or constructing structures such as hut is prohibited.
- iii. Littering and waste disposal is strictly banned.
- iv. Cutting or uprooting vegetation for any purpose is prohibited.
- v. Coral collection, shell collection, sand and coral mining or plant collection

## **Penalty**

- i. If a party or an individual is found guilty of breaching, the party or individual will be penalized with 5,000/- Mrf and fine increases to Mrf 10,000/- if a party or an individual in found entering Hanifaru island between 6:00pm to 6:00 am.
- ii. If a party or an individual is found guilty of disposing waste, destroying vegetation and collection of any material from Hanifaru Island, party or individual will be penalized with 5,000/- to 10,000/- Mrf.
